**ORDER 2016 (No 2) - NOTICE OF PROPOSALS**

Notice is hereby given that the Wyre Forest District Council ("the Council") in exercise of its powers under Section 32 of the Road Traffic Regulation Act 1984 and of all other enabling powers proposes to make the above Order. The Order shall come into effect on 3<sup>rd</sup> July 2016. The effect of the Order shall be:

1. To revoke the current Order and reinstate those provisions save for the amendments proposed;
2. To remove the following car parks from the Order: Stourport Sports Centre Surface Car Park (No.1); Stourport Sports Centre Surface Car Park (No 2); Stourport Sports Centre Surface Car Park (No 3).

A copy of the Order, plans showing the land affected and a statement of the Council's reasons for making the Order can be inspected between 09:00 and 16:30 Monday to Friday at Wyre Forest House, Kidderminster and the Worcestershire Hub, Town Hall, Kidderminster and on the Council's website. If you wish to object to this Order, the objection together with the grounds for making it must be made in writing to the Solicitor of the Council, Wyre Forest District Council, Wyre Forest House, Finepoint Way, Kidderminster, DY11 7WF **not later than 4pm on 16<sup>th</sup> June 2016.**

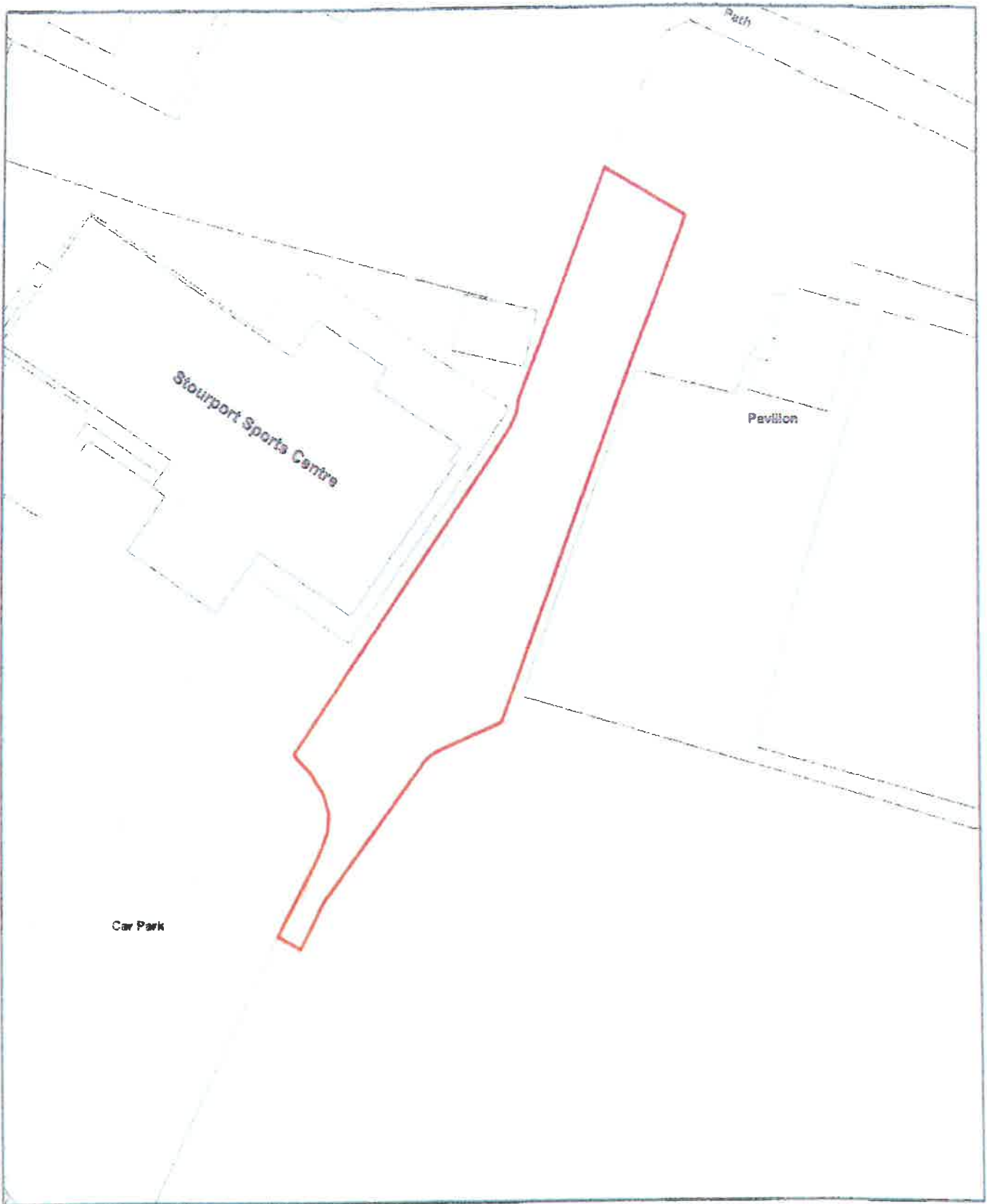

**ROAD TRAFFIC REGULATION ACT 1984

**Statement of Reasons**

1. For the purpose of this Statement of Reasons references to 'Car Parks' shall be to the land outlined in red on the attached plans.
2. As part of the Council's review of leisure facilities within the district the Stourport Sports Centre will close shortly before the new leisure centre at Silverwoods opens in July 2016. Upon the closure of the Stourport Sports Centre the Car Parks are no longer required as their primary function is to service visitors to the centre.
3. The site is included within the Council's Strategic Asset Management Plan 2016, the sale proceeds of the site will contribute to the costs of the new leisure centre.
4. On 6<sup>th</sup> May 2016 the Cabinet (through a Strong Leader decision) agreed the disposal of the Stourports Sports Centre and associated car parks.
5. It was also agreed that the Car Parks shall be removed from the Wyre Forest District Council (Off Street Parking Places) Order 2016 subject to the statutory consultation process and the consideration of any objections received to enable the disposal free from the parking order.



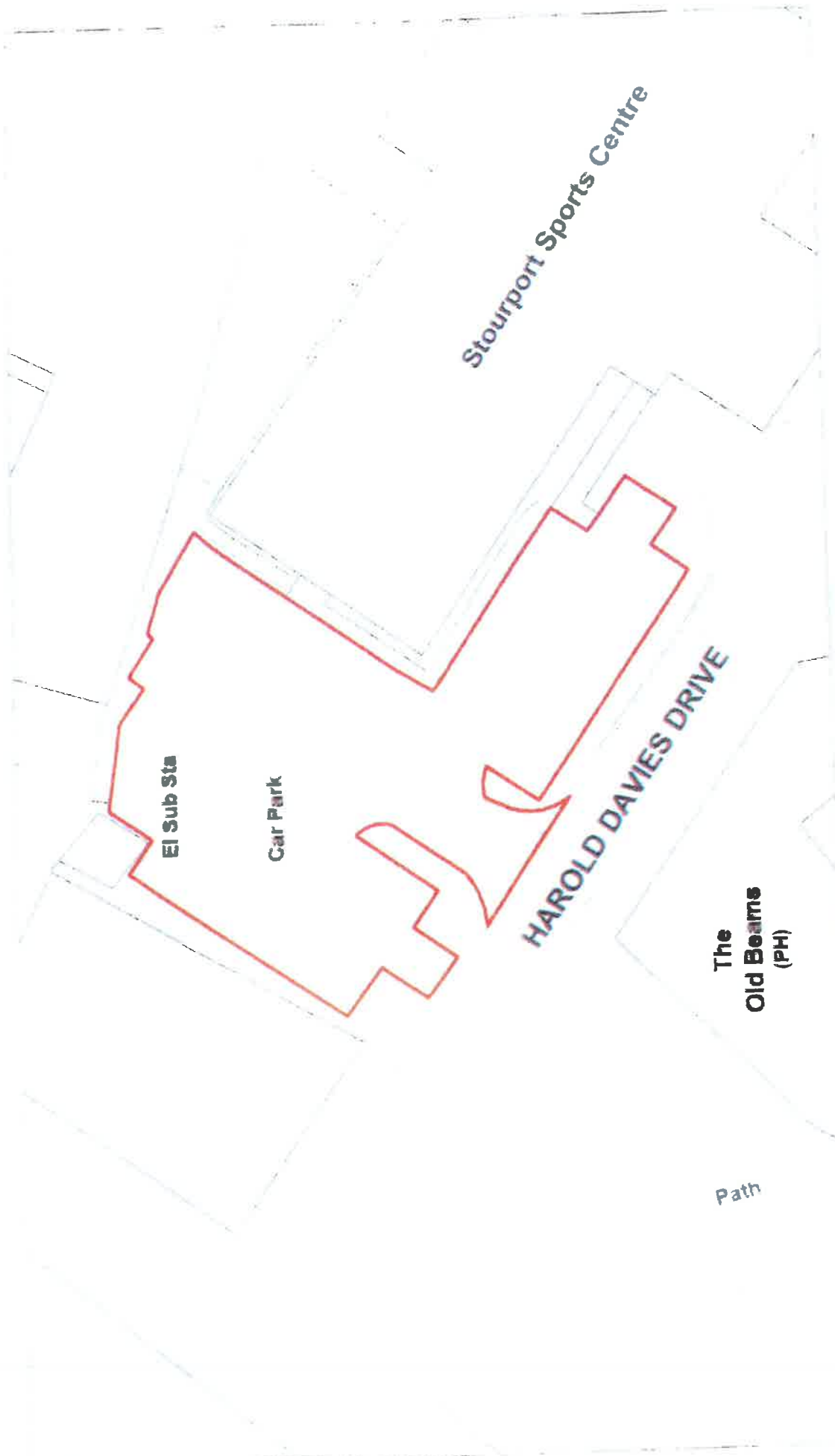
Stourport Sports Centre Surface Car Park (No.3), Stourport-on-Severn
