**Basic Allowance**

**Special Responsibility Allowance**

A Special Responsibility Allowance is also payable to some Councillors' who hold positions of responsibility within the Council i.e. Leader, Deputy Leader, Cabinet Member, Committee Chair or Vice Chair

**Travel**

Councillors' are entitled to claim travel allowance when they incur expenditure whilst undertaking official Council business
