Latterly, in my capacity as an ALM (Authorised Lay Minister) at St Cassian's Church I have reconnected with Mrs Smith and her youngest daughter Naomi who have become members of our Family service congregation. They are very much part of this community and to uproot a settled family that needs the security and the surety of a permanent residence would be detrimental to an entire family. Two of the family are employed in fulltime and part time roles at Chaddesley Corbett Primary School. Naomi is a pupil there and needs the extra support which this school can give.

I ask you, that as Mrs Smith and her family have been at the Top Acre address for many years, that permission will be granted for them to stay. To refuse to grant this permission, I believe, would lead to this family unit of young people and young adults going down the path of vulnerability. The best chance they have for a successful life is to stay where they are and I implore you to look at their case sympathetically and with compassion.
