STONE PARISH COUNCIL Annual Report 2014 – 2015

Introduction

I am pleased to be able to send you Stone Parish Council's Annual Report for the last financial year, which sets out to tell you what we have achieved for the good of the parish in the last year, and how the money raised by the Parish Precept was spent.

Parish Precept

Last year we were able to lower the Parish Precept by 3.4%. However, in this financial year, there has been a reduction of our annual grant from the Wyre Forest District Council of £339 (£185 of which is the Churchyard Maintenance Grant) In light of this your Parish Council thought it prudent to increase the precept by 2%.

Grant for upkeep of Stone Church Graveyards

Although the Grant from Wyre Forest District Council has been reduced by £185, before actually ceasing, we decided to make a grant of £750 for maintenance of the graveyard on Butts Lane where so many members of the parish are buried.

St. Mary's Church, Stone

Although this is totally separate from the Parish Council, we have asked the vicar, the Reverend Robert Legge to contribute to this report, which is as follows:-

During the past year we have continued to fulfil our share of weddings and baptisms, delighting in the fact that so many couples instantly fall in love with the serenity and beauty of our church when they first enter it. This is reflected in the number of couples who contact me to request a wedding or baptism. We have also had prayer and reflective times at Halloween and in the run up to Christmas. We hope to continue these events so please watch out for further details. In addition, we have recently had our annual Bluebell Walk, raising a total of around £200 for our church funds.

As always parking at the church continues to be an issue and I would like to take this opportunity, as vicar of the church to thank Mr James Arbuthnott for letting us use his field for parking. It is very much appreciated. Thanks must also go to the Parish Council for their annual contribution to the upkeep of the graveyard in Butts Lane.

It may be that you have lived in the area for some time and yet have never had the chance to see around the church.
